Section 1: Vision Statement

Comment on:

- This document is written as part of the requirement placed on schools under the Equality Act 2010 to have an accessibility plan.
- The purpose of the plan is to show how St Philips Church of England Primary School intends to increase the accessibility of our school for disabled children where necessary.
- A person has a disability if they have a physical or mental impairment that has a substantial and long-term adverse effect on their ability to carry out normal day to day activities.
- The very nature of the School Missions Statement, Visions, Community and British Values underpin this plan.
- This plan links to a variety of policies and documents used with the School e.g. SEND policy, SEN report, Behaviour Policy, PE policy, Inclusion Policy etc.
- This plan will be shared through the school website.
- The plan will be monitored annually by the Governing Body and termly by the SLT.
- The plan sets out the proposals of the Governing Body of the School to increase access to education for disabled pupils in the three areas required by the planning duties in the DDA.
 1. Increasing the extent to which disabled pupils can participate in the school curriculum (this includes teaching and learning and the wider curriculum of the school such as participation in after school clubs, leisure and cultural activities or school visits).
 2. Improving the environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services (this includes improvements to the physical environment of the school and physical aids to access education).
 3. Improving the delivery to disabled pupils of information which is provided in writing for pupils who are not disabled (this will include planning to make written information that is normally provided by schools to its pupils available to disabled pupils (examples might include handouts, timetables, textbooks and information about school events). The information should take account of the pupils' disabilities and the preferred format of pupils and parents and be made available with a reasonable timeframe.
- Training will form part of the accessibility plan.
- The School Complaints Procedure is available on the school website.
